

# Importing Personal Property Into HONG KONG

## IMPORTING HOUSEHOLD GOODS AND PERSONAL EFFECTS

#### DUTY-FREE ENTRY IS PERMITTED IF THE FOLLOWING REQUIREMENTS ARE MET:

- The Hong Kong Special Administrative Region of the People's Republic of China (HKSAR of the PRC) is a free port and does not levy any Customs tariffs or taxes on imports.
- The shipper can import personal and household goods by air, sea, or both only once within the first 6 months after the Import Permit is issued. Any subsequent shipments are subject to greater import tax and duty and/or seizure by the Chinese Customs authorities.
- Returning local residents who have spent less than 24 hours outside HKSAR and persons under the age of 18 are not eligible for duty-free concessions.

#### Notes:

- You must have a contact address and telephone number in Hong Kong.
- You must be in China at the time your goods and effects clear Customs .
- All air shipments will be inspected and surface shipments are inspected randomly.

#### **REQUIRED DOCUMENTS:**

- Residence Visa
- Work Visa
- Detailed Inventory avoid using term "miscellaneous" to describe items.
- ✓ Original Bill of Lading or Air Waybill
- Copy of the shipper's passport, re-signed by the shipper.
- Letter of authorization to Customs and Excise Department (Power of Attorney)
- Completed and signed "Application Form for Import/Export of Personal Effects."

#### **PROHIBITED ITEMS**

- Narcotics (such as Opium, Morphine, Heroin, Cocaine, Cannabis, Methadone, etc.)
- Psychotropic drugs including most stimulants, hypnotics, tranquilizers and sedatives
- Antibiotics
- Controlled chemicals (such as Acetic Anhydride, Ephedrine, etc.)
- Perishable food items
- Pornographic or politically subversive material.
- Endangered Species including animals and plants or parts or derivatives of such species.
- Counterfeit goods, or infringing copies of computer software, compact discs or music cassette tapes. You will be subject to criminal prosecution if you import these items.

#### **RESTRICTED/DUTIBLE ITEMS**

A license is required for the importation of any of the following items:

- Alcohol, which is defined by any liquid containing more than 1.2% of ethyl alcohol.
- Tobacco products
- Firearms and ammunition
- Weapons Chinese-style throwing dart, knuckle-duster, gravity knife and gravityoperated baton.
- Fireworks
- Personal Computers (import permit required for machines with a power level higher than Pentium III
- Plant and vegetable products require an Import License and a valid *Phytosanitary Certificate*. Shipper must also provide the following documents: Original Purchase Invoice, Certificate of Registration, and Insurance Certificate.

## **IMPORTING PETS, FIREARMS AND MOTOR VEHICLES**

#### **IMPORTATION OF PETS:**

You must obtain a permit from the **Agriculture** and **Fisheries Department** prior to importing mammals, birds and/or reptiles. Quarantine is usually required and the length depends on type of pet and origin.

#### **REQUIRED DOCUMENTS:**

- International Health Certificate dated no more than 14 days prior to departure, endorsed by a Government approved Veterinarian.
- ✓ Import License.
- Rabies vaccination certificate. The rabies vaccination must be administered at least 30 days prior to departure and not more than 6 months before departure.

#### **IMPORTATION OF FIREARMS:**

A license must be obtained from the Trade Department for importing firearms and ammunition.

#### **IMPORTATION OF MOTOR VEHICLES:**

- All motor vehicles are subject to a First Registration Tax assessed on the published retail price of the vehicle.
- An import return must be filed with the Customs and Excise Department within 30 days of importation.
- The shipper must have owned the vehicle for at least 6 months.

#### **REQUIRED DOCUMENTS:**

- Import license Form 3 for right-hand drive vehicles.
- Bill of lading or airway bill
- ✓ Passport
- ✓ Hong Kong Insurance Certificate
- Full Exhaust Emission Test Certificate obtained prior to departure.
