# IMPORTING HOUSEHOLD GOODS/ PERSONAL EFFECTS AND MOTOR VEHICLES

#### DUTY-FREE ENTRY IS PERMITTED IF THE FOLLOWING REQUIREMENTS ARE MET:

• The goods have been owned and used by the shipper for at least 12 months.

#### Notes:

• Shipper must be present at the time of customs clearance.

#### **REQUIRED DOCUMENTS:**

- ✓ Passport
- ✓ Bill of Lading or Air Waybill
- Packing List
- Insurance Certificate

#### **RESTRICTED/DUTIBALE ITEMS:**

- Firearms require a special Import Permit and incur high rates of duty.
- Items covered under "Barbados Miscellaneous Control Act" including motor vehicles, new furniture, etc. require Import Permits.
- Meat requires a health certificate and inspection by Port Health authorities.
- Plants require an Import License and inspection by the Ministry of External Affairs, Christ Church, Barbados.
- Jewelry, watches and clocks incur duty and tax.

# RESTRICTED/DUTIBALE ITEMS (CONTINUED):

- All fruits, vegetables, cuttings, seeds or unprocessed plant products are restricted and therefore must be declared to customs for inspection by a Plant Quarantine Officer. Certain fruit is prohibited to prevent the spread of diseases. Certain plants, seeds, cuttings are restricted and require an Import Permit and phytosanitary certificate. #### **PROHIBITED ITEMS:**

- Illegal drugs
- Firearms and ammunition
- Pornography

#### **IMPORTATION OF MOTOR VEHICLES:**

 Duty must be paid on motor vehicles and an Import Permit must be obtained from the Ministry of External Affairs, Christ Church, Barbados.

#### **REQUIRED DOCUMENTS:**

- ✓ Import License
- ✓ Insurance policy
- Owner's log book
- Commercial invoice

## **IMPORTING PETS**

#### **IMPORTATION OF PETS:**

- Prior to departure, an Import Permit must be obtained from the Chief Veterinary Officer for importing any type of animal, reptile and/or bird.
- Dogs and cats free of any communicable disease may be imported with an Import Permit from the following countries: UK, Ireland, Jamaica, St. Kitts – Nevis, Antigua, St. Lucia and St. Vincent. Cats and dogs from any other country must be quarantined in the UK for a period of 6 months.
- A Veterinary Officer must inspect the pet at the customs area.
