

### **Importing Personal Property Into**

## **CHILE**

#### IMPORTING HOUSEHOLD GOODS AND PERSONAL EFFECTS

# DUTY-FREE ENTRY IS PERMITTED IF THE FOLLOWING REQUIREMENTS ARE MET:

- The following personal effects may be imported duty-free: travel articles, clothing and electrical appliances used for personal use.
- Goods previously exported from Chile can be re-imported duty-free.
- The effects are owned by diplomats, administrative employees of diplomatic missions, employees of international organizations, employees from foreign businesses sent to work in Chile and Chilean national returning from diplomatic assignment overseas.
- Returning Chilean citizens who held residence abroad for at least 6 months can import up to U\$\$500.00 (F.O.B.) worth of household goods duty-free.
- Returning Chilean citizens who held residence abroad for more than one year can import up to U\$\$3,000.00 (F.O.B.) worth of household goods duty-free.
- Returning Chilean citizens who held residence abroad for more than 5 years can import up to US\$5,000 (F.O.B.) worth of household goods duty-free.
- Foreigners who hold a temporary visa or a work visa for more than one year can import up to US\$5,000 (F.O.B.) worth of household goods duty-free.

#### Notes:

- The shipper must be in Chile prior to the shipment's arrival, no exceptions are granted.
- Shipment must arrive within 120 days of shipper's arrival.

#### **REQUIRED DOCUMENTS:**

- ✓ Original Bill of Lading or Airway Bill
- Passports of all family members
- ✓ Visa

#### **REQUIRED DOCUMENTS (CONTINUED):**

- ✓ Work Contract
- ✓ Power of Attorney
- ✓ An inventory of all electrical items listing the brands of each item.
- ✓ Signed, legible packing list in English or Spanish, with no values included for Customs purposes.
  - ✓ List the following information for each item on the inventory: trademarks, model numbers, serial numbers, description of items, materials that the item is made of, and year of acquisition.
- ✓ Returning Chilean nationals require:
  - ✓ A Chilean identification card
  - Departure documents

#### **RESTRICTED/DUTIBALE ITEMS:**

- Meat products, flowers, fruits and vegetables require certificates legalized by a Chilean consulate.
- Firearms (for sporting use ONLY) require a permit obtained from the Weapons Control Bureau. Item will be held at customs until permit arrives.
- Alcohol and tobacco products
- New furniture is subject to duties and requires invoices.
- Caviar
- Pearls
- Synthetic furs
- Uncut precious, semi-precious or synthetic stones

#### **PROHIBITED ITEMS:**

- Drugs
- Pornographic materials

#### **IMPORTING MOTOR VEHICLES AND PETS**

#### PROHIBITED ITEMS (CONTINUED):

- Meat products that are not canned
- Products made from endangered species

#### **IMPORTATION OF MOTOR VEHICLES:**

- All vehicles are subject to very high duties and taxes.
- Diplomats, foreign diplomatic personnel or returning Chilean diplomats are exempted from paying duties (limit 1 vehicle).
- Duties are based upon make, model, year, engine's cubic capacity, transmission type, extras and purchase value.
- Only returning Chilean citizens and diplomats are permitted to import used vehicles.
- NO used motorcycles are allowed
- Shipper will pay full import duties, approximately 34% of the vehicles value for used and new vehicles.

#### **REQUIRED DOCUMENTS:**

- Original purchase invoice
- Endorsed original bill of lading
- Vehicle identification certificate

# REQUIRED DOCUMENTS FOR MOTOR VEHICLE (CONTINUED):

- ✓ Final cost certificate
- ✓ Internal tax receipt
- Passport

#### **IMPORTATION OF PETS:**

- Dog and cats are allowed importation into Chile with the proper documentation.
- Chile has no guarantine requirements.
- If pet arrives unaccompanied then duties must be paid.

#### **REQUIRED DOCUMENTS:**

- Health Certificate legalized by a Chilean consulate.
- Vaccination Certificate legalized by a Chilean consulate.
- ✓ Invoice stating pet's name, breed, weight, color and value for Customs purposes.
